

MEMORANDUM OF AGREEMENT

BETWEEN

**THE CARPENTERS' EMPLOYER BARGAINING AGENCY
("E.B.A.")**

-AND-

**THE CARPENTERS' DISTRICT COUNCIL OF ONTARIO, UNITED BROTHERHOOD OF
CARPENTERS AND JOINERS OF AMERICA
("C.D.C.")**

WHEREAS the E.B.A. and C.D.C. have previously entered into a Collective agreement in the Industrial, Commercial and Institutional sector for the period of May 1, 2010 through April 30, 2013 (the "Carpenters' Provincial Collective Agreement");

AND WHEREAS following the publication of the Carpenters' Provincial Agreement certain typographical errors were identified by both the E.B.A. and C.D.C. in some of the Local Union Appendices;

AND WHEREAS the parties wish to address and clarify these typographical errors in the Local Union Appendices;

NOW THEREFORE the parties agree as follows:

1. **Carpenters' Schedule "D" Local 27 (Barrie):** Page 70 of the Carpenters' Provincial Collective Agreement shall be amended to include the previously omitted Promotional Fund as follows:

2. **Acoustic/Drywall Schedule "D" Local 494 (Windsor):** Page 186 of the Carpenters' Provincial Collective Agreement shall be amended to reflect the appropriate Employer Contribution as follows:

3. **Acoustic/Drywall Schedule "D" Local 1669 (Thunder Bay):** Page 204 of the Carpenters' Provincial Collective Agreement shall be amended to reflect the correct date of wage increase for Apprentices as follows:


4. **Acoustic/Drywall Schedule "D" Local 1946 (London):** Page 211 of the Carpenters' Provincial Collective Agreement shall be amended to reflect the correct date of wage increase for Apprentices as follows:

May 1/10 May 1/11 **May 1/12**

5. **Acoustic/Drywall Schedule "D" Local 1946 (London):** Page 212 of the Carpenters' Provincial Collective Agreement shall be amended to omit the following language from item (d) : "and/or because the work required to be done is in occupied premises."
6. All other terms and conditions contained in the Carpenters' Provincial Collective Agreement shall remain unchanged and in full force and effect.
